2.On the complaint given by the petitioner with respect to assault and threats committed by the third respondent, a first information report in Crime No.4 of 2026 came to be registered by the second respondent police on 04.01.2026. Even after the registration of the FIR, the third respondent is continuously preventing the petitioner and his staff from discharging their duty in the college viz. Seethalakshmi Achi College for Women and Endowment Trust at Pallathur, Sivagangai District. Hence, the petitioner has filed this petition seeking aforesaid prayer.

3.The learned counsel for the petitioner produced certain video recording, which would throw light on the aggression that had happened
