ORDER

This Civil Revision Petition has been filed seeking a direction to the learned Principal Subordinate Judge, Dindigul, to dispose of the suit in O.S.No.33 of 2004, within a time frame fixed by this Court.

2.This Court, vide order, dated 06.02.2026, had directed the learned Principal Subordinate Judge, Dindigul, to send a year wise pendency report of the pending cases and in compliance of the same, the learned Principal Subordinate Judge, Dindigul, had sent a report vide proceedings in D.No. 190/2026, dated 26.02.2026, annexing the breakup details with regard to the pendency of the cases arising from the year 1987 to 2026. From the perusal of the same, it is seen that the total number of pending cases is 1653 and the
