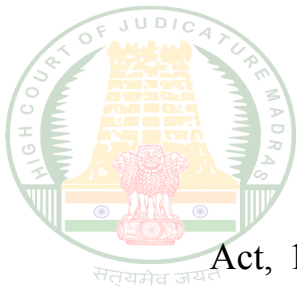

3. Recording the same, this Contempt Petition is closed.

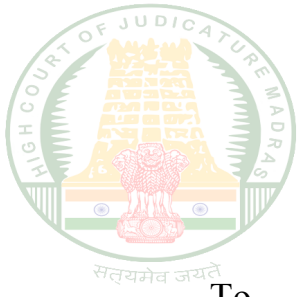
