ORDER

2.The case of the petitioners is that the 4th respondent / then principal of the college has committed misappropriation, which has been pointed out along with records to the respondents. However, the Joint Director / the 3rd respondent has not taken any action.

3.When this writ petition is taken up for hearing, the learned Additional Government Pleader based on the written instructions provided to him submits that the Director of School Education, by proceedings dated 10.02.2026 constituted a committee consisting of Regional Joint Director, Trichy and Assistant Director, Dharmapuri to enquire into the complaint of the petitioners and it would be concluded within a period of twelve weeks.

4.Since a committee has been constituted to enquire into the complaints of the petitioners, this writ petition is closed. No costs.
