This Writ Petition is filed seeking a direction to the respondent to disburse the amount to the petitioner for installation of CCTV cameras at Ramnad District to a sum of Rs. 4,92,190/- (Rupees Four Lakhs ninety two thousand and one hundred and ninety only) by considering petitioner's representation dated 12.06.2025 within the period that may be stipulated by this Court.

2. By consent, this Writ Petition is taken up for final disposal at the admission stage itself.

The petitioner has made a representation on 12.06.2025, seeking to disburse the amount to the petitioner for installation of CCTV cameras at Ramnad District to a sum of Rs. 4,92,190/- (Rupees Four Lakhs ninety two thousand and one hundred and ninety only). Since the said representation was not considered till date, the petitioner has filed this Writ Petition.

6. With the above directions, this Writ Petition is disposed of. There shall be no order as to costs.
