This writ petition has been filed seeking the issuance of a writ of mandamus, directing respondents 2 to 4 to cancel the patta bearing No. 4428 dated 13.10.1992, standing in the name of the 6th respondent society, by reclassifying the vacant land as a public pathway, comprised in Survey Nos. 131/1B1 and 131/1AS1, measuring 12 feet in breadth and

390 feet in length, situated at T.S. Ramalinga Nagar, Palayampatti Village, Aruppukkottai Taluk, Virudhunagar District, based on the petitioner's representation submitted to respondents 1 to 5 dated 10.01.2024, within a time frame as may be stipulated by this Court.

2. When the matter was taken up for hearing, learned Special Government Pleader appearing on behalf of respondents 1 to 6 submitted that the patta had already been cancelled and, therefore, nothing survives for adjudication.

3. Recording the aforesaid submission, this writ petition stands dismissed as infructuous. There shall be no order as to costs.
