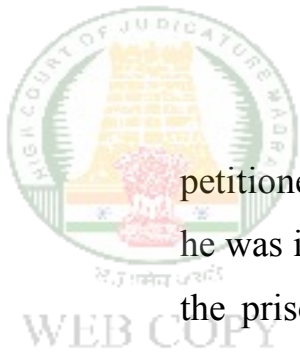

Prayer:

ORDER
