Considering the submissions made by the learned counsel on both sides, this Court directs the respondents to consider the petitioner's representation dated 19.01.2026 and grant permission to conduct the cultural programs scheduled on 28.01.2026, with the timing restricted from 06:00 p.m. to 09:00 p.m., in connection with the Jeernotharana Astabanthana Maha Kumbavisegam festival of Arulmigu Sri Selva Vinayagar, Sri Karkuthi Ayyanar, Sri Kaliamman, and Sri Ruthrakaliamman at Avitanallavijayapuram, Chinnakumulai Village, Orathanadu Taluk, Thanjavur District. Furthermore, the petitioner is directed to record the entire event without editing and produce the same before this Court on 30.01.2026.

4. With the above direction, this Writ Petition is disposed of.
