ORDER

[Order of the Court was made by G.K.ILANTHIRAIYAN, J.]

This writ miscellaneous petition has been filed for extension of emergency leave which was granted by this Court vide order dated 19.01.2026 passed in WP.Crl.(MD).No.2717/2025 for 7 days i.e., till today, on the ground that the petitioner is suffering from knee pain and she was advised to undergo knee replacement surgery.
