2.The case of the writ petitioner is that the petition mentioned water body was encroached upon by a local religious body and that the revenue record was also wrongly mutated. Even though the proposal was submitted way back in the year 2019 and reiterated in the year 2024, the first respondent has not yet passed any order till date. That led to the filing of this writ petition.
