2.The petitioner herein filed W.P(MD)No.23198 of 2024 for removing the encroachment said to have been made by the fifth respondent in the writ petition. The said writ petition is disposed of on 11.08.2025 with a direction to the authorities to complete the action for removal of the encroachments pursuant to the earlier direction given by the Division Bench.

3.The Revenue Inspector, Kovilur thereafter issued notice under Section 7 of the Land Encroachment Act, 1905. It is stated that, challenging the action taken by the authorities, the fifth respondent herein filed W.P(MD)No.4861 of 2026 and that the Division Bench has granted stay of the action by the authorities.
