ORDER

This Writ Petition has been filed seeking issuance of a Writ of Mandamus directing the second respondent to consider and pass appropriate orders on the representation of the petitioner dated 15.12.2025 within a stipulated time as may be fixed by this Court.

2. With the consent of the parties, this Writ Petition is taken up for final disposal at the admission stage itself.

3. The grievance of the petitioner is that she is a poor Adi Dravidar woman and a long-standing occupant of a free house site comprised in Survey No.141/23, Natham Village, Kamuthi Taluk, Ramanathapuram District. Since the original assignee violated the conditions of assignment by alienation and non-occupation, after due enquiry, the Special Tahsildar (Adi Dravidar Welfare), by proceedings dated 24.08.2011, and the Revenue Divisional Officer, by proceedings dated 10.03.2011, recommended cancellation of the original assignment and grant of fresh

the same has been correctly filed and dispose of the same on its merits and in accordance with law within a period of sixteen weeks from the date of receipt of a copy of this order. The representation/appeal shall be disposed of after conducting an enquiry. The second respondent is also directed to provide a reasonable opportunity of hearing to the petitioner and any other interested parties who may be affected by such decision, before passing any order. There shall be no order as to costs.
