Today, when the matter is taken up for hearing, Mr.J.Ashok, learned Additional Government Pleader, who takes notice for the respondents, on instructions, submits that the survey number of the land, which is in illegal occupation of the petitioner herein is 142 and not 175 and hence, the authority concerned has proposed to withdraw the impugned notice and issue a fresh eviction notice with correct survey number.

3. Recording the proposal of withdrawal of the impugned notice citing error in the survey number, this writ petition is dismissed. No costs. Consequently, connected miscellaneous petition is closed.
