This Criminal Miscellaneous Petition has been filed to relax the condition No.6(iii) imposed upon Revision Petitioner in Crl.M.P.(MD)No.20243 of 2025 in Crl.R.C(MD)No.1641 of 2025, dated 18.12.2025. Condition No.6(iii) reads as under:-

“6.

(iii) The petitioner shall appear and sign before the learned Judicial Magistrate-I, Kulithalai, on all working days until further orders;”

2.Heard Mr.K.Suresh, learned counsel for the Revision Petitioner and Mr.P.Kottaichamy, learned Government Advocate for Respondent.

3. Learned counsel for Revision Petitioner submits that Revision Petitioner has been regularly complying with the conditions imposed by this Court dated 18.12.2025 in Crl.M.P.(MD)No.20243 of 2025 in Crl.R.C(MD)No.1641 of 2025. He prays that Condition No. 6(iii) of the order dated 18.12.2025, imposed on Revision Petitioner, may be relaxed. He further prays that Revision Petitioner may be directed to appear before the Trial Court once in a month.

5. Taking into consideration the submissions made by learned Counsel on both sides, condition No.6(iii) imposed by this Court in Crl.M.P.(MD)No.20243 of 2025 in Crl.R.C(MD)No.1641 of 2025, dated 18.12.2025, is modified as follows:-

“6.
(iii) *The petitioner shall appear and sign before the learned Judicial Magistrate-I, Kulithalai, **once in a month** ie., on the first working day of Every English Calendar month, until further orders;*”

6. With the aforesaid modification, this Criminal Miscellaneous Petition stands ordered.
