2. The second respondent has filed a status report. A perusal of the report reveals that, upon inspection of the said site, no permanent structure or encroachment was found to exist on the public pathway. Only thorny shrubs and a few damaged cement roofing sheets were found at the site.

3. The learned Additional Government Pleader appearing for the first respondent submitted that the aforesaid materials were duly cleared and removed subsequent to the inspection.

4. In view of the above submission, nothing survives for adjudication in the writ petition. Accordingly, the writ petition stands dismissed. There shall be no order as to costs.
