4.Learned Additional Government Pleader appearing for the respondents would submit that the representation of the petitioner would be considered in accordance with law, within a time frame to be fixed by this Court.

5.Accordingly, this Writ Petition is disposed of, by directing the respondents to consider the representation of the petitioner dated 23.01.2026 and pass appropriate orders within a period of eight [8] weeks from the date of receipt of a copy of this order.
