2. When the matter was taken up for hearing, the learned Additional Government Pleader appearing for respondents 1 to 7 submitted that the Tahsildar and the Revenue Divisional Officer had already been sent a recommendation for removal of the entries in respect of the subject property marked as “Blocked” to the District Collector, who, in turn, would forward the same to the respondents 1 and 2.

3. In view of the above submission, this writ petition stands disposed of by directing the third respondent/District Collector to forward the recommendation to respondents 1 and 2. Upon receipt of the same, respondents 1 and 2 shall consider it and pass appropriate orders on merits and in accordance with law, within a period of four weeks thereafter. There shall be no order as to costs.
