ORDER

The Transfer Civil Miscellaneous Petition has been filed seeking orders to withdraw the case in I.D.O.P.No.35 of 2025 from the file of the Principal District Court, Pudukkottai and transfer the same to the Principal District Court, Thanjavur.

2. It is not in dispute that the marriage between the parties was solemnized on 21.08.2023 as per Christian rites and customs and due to their wed-lock, they were blessed with a male child aged about 2 ½ years and that subsequently, there arose some misunderstanding between them and they are living separately.

3. It is also not in dispute that the respondent has filed a petition in I.D.O.P.No.35 of 2023, seeking divorce and the same is pending on the file of the Principal District Court, Pudukkottai. He would submit that the petitioner is residing at Thanjavur District and finds it very difficult to travel to Pudukkottai along with her 2 ½ years old child to attend all the hearings.

4. The learned counsel for the respondent would submit that the petitioner has not assigned any valid reason or ground for seeking transfer of the case and that, therefore, the respondent is opposing the transfer.

5. In the case of *N.C.V.Aishwarya Vs. A.S.Saravana Karthik Sha* reported in **2022 Live Law (SC) 627**, the Hon'ble Supreme Court has reiterated the position with generally, it is the wife's convenience, which must

be looked at while considering the transfer petition under Section 24 of the Code of Civil Procedure and the relevant passage is extracted hereunder :

“The cardinal principle for exercise of power under Section 24 of the Code of Civil Procedure is that the ends of justice should demand the transfer of the suit, appeal or other proceeding. In matrimonial matters, wherever Courts are called upon to consider the plea of transfer, the Courts have to take into consideration the economic soundness of both the parties, the social strata of the spouses and their behavioural pattern, their standard of life prior to the marriage and subsequent thereto and the circumstances of both the parties in eking out their livelihood and under whose protective umbrella they are seeking their sustenance to life. Given the prevailing socioeconomic paradigm in the Indian society, generally, it is the wife's convenience which must be looked at while considering transfer.”, the bench observed.”

6. Considering the facts and circumstances of the case and taking note of the fact that the petitioner is residing at Thanjavur, this Court is inclined to allow this petition. Accordingly, the petition in I.D.O.P.No.35 of 2025, is ordered to be withdrawn from the file of the Principal District Court, Pudukkottai and transfer the same to the Principal District Court, Thanjavur. The learned Principal District Judge, Pudukkottai, is hereby directed to transmit the entire records in I.D.O.P.No.35 of 2025 to the file of the Principal

District Court, Thanjavur, within a period of 10 days from the date of receipt of a copy of this order and on receiving the case bundle, the learned Principal District Judge, Thanjavur, is directed to take up the petition on file and proceed in accordance with law.

7. With the above direction, the Transfer Civil Miscellaneous Petition stands allowed. Consequently, connected Miscellaneous Petition is closed.
