ORDER

This Criminal Original Petition has been filed to direct the learned District and Sessions Judge (Special Court for PCR Cases), Pudukkottai to accept the surrender of the petitioner and consider his bail application on the same day.

2. Considering the nature of the relief sought for, notice to the 3rd respondent is dispensed with.

3. The case of the prosecution is that due to the landlord and tenant dispute, on 29.01.2026, an altercation occurred between the petitioner and the *de facto* complainant, resulting in the petitioner allegedly scolding and assaulting the *de facto* complainant. Based on these allegations, an FIR has been registered against the petitioner.

4. Heard the learned counsel on either side and carefully perused the materials available on record.
