The learned Additional Government Pleader appearing for the respondents, on instructions, submitted that, by a letter dated 20.03.2026, a communication has been sent to the petitioner requesting her to submit a genealogy report. If the genealogy report is filed, necessary orders will be passed on merits.

3. In view of the above, this Court, without going into the merits of the claim made by the petitioner, directs the petitioner to submit a reply to the communication dated 20.03.2026 addressed to her, within a period of two weeks from the date of receipt of a copy of this order. On receipt of the same, the first respondent shall consider it and pass orders on merits and in accordance with law, after affording the petitioner due opportunity of personal hearing. Such exercise shall be completed within a period of two months from the date of receipt of a copy of the reply.
