2. Recording the same, the Criminal Miscellaneous Petition is dismissed as withdrawn.

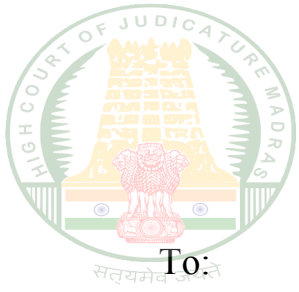
3. Registry is directed to prepare the paper book and list the appeal for final hearing in the usual course.
