ORDER : The Court made the following order :-

The petitioner, who apprehends arrest at the hands of the

respondent police for the offences punishable under Sections 296(b), 131, 126(2), 308(4) and 351(3) of BNS @ Sections 191(2), 191(3), 126(2), 296(b), 131, 318(4), 308(4), 3(5), 61(2) and 351(3) of BNS, 2023 in Crime No.540 of 2025 on the file of the respondent police, seeks anticipatory bail.

2. The case of the prosecution is that, upon coming to know about the alleged illegal intimacy of the de facto complainant, the petitioner herein is said to have threatened the de facto complainant and demanded a sum of Rs.50,000/- for not disclosing the same to his family. Hence, the complaint.

3. The learned Government Advocate (Crl. side) submits that there is no previous case pending against the petitioner and the co accused has already been arrested and released on bail.

4. Heard the learned counsel appearing for the petitioner and the learned Government Advocate (Criminal Side) appearing for the respondent police.

5. Considering the specific overt act attributed against the petitioner and also the fact that there is no previous case pending against him, this Court is inclined to grant anticipatory bail to the petitioner, subject to certain conditions.

5. Accordingly, the petitioner is ordered to be released on bail in the event of arrest or on his appearance, on condition that the petitioner shall execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate No.III, Thiruchirappalli, within a period of fifteen days from the date of receipt of a copy of this order and on further conditions that:

[a] the petitioner and the sureties shall affix their photographs and left thumb impression in the surety bond and the Magistrate may obtain a copy of their Aadhaar card or bank pass book to ensure their identity;

[b] The petitioner shall serve in the wards and assist the staff in cleaning the ward for two weeks at Government Hospital, Trichy and the said service shall be certified and reported to the investigating Officer by the concerned Nursing Superintendent and thereafter, he shall report before the respondent police daily at 10.00 a.m., until further orders. Relaxation petition will not be entertained for the next two months.

[c] the petitioner shall not tamper with the evidence or witness either during investigation or trial.

[d] the petitioner shall not abscond either during investigation or trial.

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner are released on bail by the learned

Magistrate/Trial Court himself as laid down by the
Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala
[(2005)AIR SCW 5560].

[f] If the accused thereafter absconds, a fresh FIR can be
registered under Section 269 of BNS.
