ORDER

This petition has been filed seeking for a direction to the respondents to secure and produce the detinue namely Jinofer Roomana, aged 21 years, before this Court.

2.The petitioner fell in love with the detinue and got married at Arulmigu Balamurugan Temple, Keelakarai, Ramanathapuram District. While being so, she was taken by her mother illegally without her consent. Thereafter, the detinue did not return to his home. Hence, the petitioner lodged a complaint before the 3rd respondent police.

3.On enquiry, the third respondent police found that the detainee is aged about 21years and she got married the petitioner and the detainee is in her mother's house. She was secured and produced before this Court. The detainee deposed that she went to her mother's house on the hope that her parents will accept their marriage. But however, on her arrival to her mother's house, her mother refused to accept her marriage and also did not permit her to visit the petitioner's house. Now, she does not want to go with her mother and she wants to go with the petitioner, who is her husband.
