PETITION FOR BAIL Under Sec.483 of BNSS

PRAYER :-

For Bail in Crime No.23 of 2025 on the file of the Respondent Police.

ORDER : The Court made the following order :-

The petitioner, who was arrested and remanded to judicial custody on 10.01.2026 for the offences punishable under Sections 5(l), 5(j)(ii) and 6 of POCSO Act in Crime No.23 of 2025 on the file of the respondent police seeks bail.

2. The case of the prosecution is that the petitioner herein is said to have committed penetrative sexual assault on the victim girl. Hence, the complaint.

3. The learned counsel for the petitioner submitted that the petitioner is innocent and he has not committed any offence as alleged by the prosecution. He further submitted that the petitioner is ready and willing to abide by any conditions which may be imposed by this Court and he is in judicial custody from 10.01.2026. Hence, he seeks bail to the petitioner.

4. The learned Additional Public Prosecutor would submit that there are three previous cases pending against the petitioner and the investigation of the case is pending and hence, he opposed for grant of

bail to the petitioner.

5. Considering the facts and circumstances of the case and also considering the period of incarceration already suffered by the petitioner, this Court is inclined to grant bail to the petitioner, subject to the following conditions:

6. Accordingly, the petitioner is ordered to be released on bail on executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties, each for a like sum to the satisfaction of the Special Court for POCSO Act cases, Virudhunagar District at Srivilliputtur, and on further conditions that :-

[a] the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity.

[b] The petitioner shall not enter into the house, school, or college of the de facto complainant and shall refrain from intimidating or threatening the victim and her family until the conclusion of the trial. Furthermore,

the petitioner shall appear before the trial court on all hearing dates without fail.

[c] the petitioner shall not abscond either during investigation or trial.

[d] the petitioner shall not tamper with evidence or witness either during investigation or trial.

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560].

[f] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 BNS.
