For Bail in Crime No.349/2025 on the file of the  
respondent police.

ORDER : The Court made the following order :-

The petitioner, who was arrested and remanded to judicial custody on 25.11.2025 for the offences punishable under Sections 304(2) @ 310(2) of BNS, 2023 in Crime No.349 of 2025 on the file of the respondent seeks bail.

2. The case of the prosecution is that the petitioner herein is said to have entered into the house of the defacto complainant and snatched 5 ½ sovereigns of gold chain from her. Hence, the complaint.

3. The learned counsel for the petitioner submitted that the petitioner has not committed any offence as alleged by the prosecution. He further submitted that the petitioner is ready and willing to abide by any conditions which may be imposed by this Court and he is in judicial custody from 25.11.2025. Hence, he seeks bail to the petitioner.

4. The learned Additional Public Prosecutor would submit that there are eight pervious cases

pending against the petitioner in similar nature and the property is not yet recovered. However, he opposed for grant of bail to the petitioner.

5. Considering the facts and circumstances of the case and also considering the period of incarceration suffered by the petitioner, this Court is inclined to grant bail to the petitioner, subject to the following conditions: :

6. Accordingly, the petitioner is ordered to be released on bail on executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties, each for a like sum to the satisfaction of the learned District Munsif Cum Judicial Magistrate, Aravakurichi, and on further conditions that :-

[a] the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity.

[b] the petitioner is directed to do social service in planting tree saplings for a period of one month; and thereafter the petitioner shall appear before the trial Court daily in the morning at 10.30 a.m and shall report before the respondent police daily evening at 05.30 p.m, until further orders;

[c] relaxation will not be considered for both the conditions for a period of three months;

[d] the petitioner shall not abscond either during investigation or trial.

[e] the petitioner shall not tamper with evidence or witness either during investigation or trial.

[f] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been

imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560].

[g] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 BNS.
