This Writ Petition is filed for issuance of a Writ of Mandamus to direct the 2nd respondent to provide police protection in conducting survey and demarcate the petitioner's landed property comprised in Survey Nos.311/2A2 and 311/2A3 total extend of 1 Acre and 22 cents relating to the petitioner's landed property situated at Nallur Village, Gujiliamparai Taluk, Dindigul District by considering the petitioner's representation dated 24.11.2025.

3. It is made clear that the petitioner is entitled for police protection for surveying the land alone and under the guise of surveying, the petitioner shall not dispossess anybody if they are
