ORDER

The present criminal original petition has been filed by the petitioner/sole accused in Spl.S.C.No.392 of 2025, on the file of the learned Principal District Court, Tenkasi, wherein the petitioner/sole accused has been charged for the offence under Sections 366(A) of I.P.C r/w Section 8 of Protection of Child From Sexual Offences Act, 2012.

2. Pending trial, the victim girl has got married to another person and she is having a child. Thereafter, the parties have entered into a compromise, wherein the de-facto complainant and the victim girl have agreed for quashing of the charge sheet as against the petitioner/sole accused.

3. Considering the fact that the victim girl is already married to another person and leading a peaceful life and she does not want to prosecute the petitioner herein, this Court is inclined to quash the charge sheet. The de-facto complainant as well as the victim girl who is aged about 20 years old are present before this Court. The husband of the victim girl is also present.
