3. Accordingly, this writ petition is disposed of. The petitioner is permitted to conduct the Maha Shivarathri Poojas with the Annadhanam function on 16.02.2026. The 2nd respondent is directed to grant appropriate permission with conditions and adequate police protection. No Costs.
