ORDER

This Writ Petition has been filed seeking issuance of a Writ of Mandamus, directing the respondent to issue Patta in the petitioner's name in respect of the

property comprised in Survey No.624, Ward No.7, R.S.No.2A Block, Plot No.59, situated at Sakkottai Union, Kottaiyur Town Panchayat, Karaikudi Taluk, Sivagangai District, by considering the petitioner's representation dated 30.01.2026, within the time frame to be fixed by this Court.

2. By consent, the Writ Petition is taken up for final disposal at the admission stage itself.

3. The learned counsel appearing for the petitioner would submit that the petitioner is the absolute owner and is in peaceful possession and enjoyment of the subject property. The petitioner submitted a representation dated 30.01.2026 to the respondent seeking issuance of Patta. However, despite the lapse of considerable time, no action has been taken on the petitioner's representation. Hence, the present Writ Petition has been filed.

4. The learned Special Government Pleader appearing for the respondent would submit that the petitioner's representation will be considered and appropriate orders will be passed on merits and in accordance with law within a time frame to be fixed by this Court.
