ORDER

Since the said representation was not considered till date, the petitioner has filed this Writ Petition.

In view of the above, this Court without going into the merits of the matter, directs the 4th respondent to consider and pass orders on the representation of the petitioner dated 22.02.2024, on merits and in accordance with law, within a period of eight weeks from the date of receipt of a copy of this order.

5. With the above direction, this Writ Petition is disposed of. There shall be no order as to costs.
