ORDER

He has submitted a representation dated 31.01.2023, requesting changes in the Revenue Records pertaining to his property. Since the same has not been considered so far, the petitioner has approached this Court by filing the Writ Petition.

4. The learned Government Advocate appearing for the respondents submits that the petitioner's representation will be considered on merits and in accordance with law.
