ORDER

3. According to the petitioner, he is in peaceful possession and enjoyment of the property in question. He has submitted a representation dated 31.01.2023, requesting changes in the Revenue Records pertaining to his property. He has also submitted *bona fide* documents supporting his claim, which establish the his rights over the property in question. Since the same has not been considered so far, the petitioner has approached this Court by filing the Writ Petition.
