The present Writ Petition has been filed seeking a Mandamus directing respondents 1 to 3 to allot one shop in the New Central Vegetable Market situated at Simmakal, Madurai, under the special category of Physically Challenged quota to the petitioner, by considering his representation dated 03.11.2025.

2. The learned Standing Counsel appearing for respondents 2 and 3 submitted that a tender notification was issued on 11.02.2026 in the newspaper inviting applications from the general public to submit their bids for allotment of shops on or before 25.02.2026. It was further submitted that Shop Nos. 26, 37, 60 and 72 have been specifically reserved for physically
