This Criminal Original Petition has been filed seeking a direction to the I Additional District Sessions Judge (Special Court for PCR), Trichy, to accept the surrender of the petitioners and consider their bail application on the same day on merits in relating to Crime No.45 of 2026 on the file of the respondent police.

3. The case of the prosecution is that the petitioners abused him by making caste-related remarks. Based on these allegations, an FIR has been registered against the petitioners.

4. Heard the learned counsel on either side and carefully perused the materials available on record.

5. Considering the limited scope of the relief sought for, this Court hereby direct the learned I Additional District Sessions Judge (Special Court for PCR), Trichy, to issue prior notice to the *de facto* complainant and thereafter, to consider the bail application of the petitioners on the same day of their surrender before that Court in connection with Crime No.45 of 2026 on the file of the 2nd respondent police. The petitioners shall surrender before the learned Trial Court within a period of 15 days from the date of receipt of a copy of this order.
