In view of the above, this Court, without going into the merits of the matter, directs the third respondent to consider and pass orders on the representation of the petitioner dated 04.02.2026, on merits and in accordance with law within a period of three (3) weeks from the date of receipt of a copy of this order.

6. With the above direction, this Writ Petition is disposed of. There shall be no order as to costs.
