ORDER

The present criminal original petition has been filed by the petitioner/sole accused in C.C.No.1 of 2026 on the file of the learned Judicial Magistrate, Thiruvaiyaru, seeking to quash the charge sheet, wherein the petitioner/sole accused has been charged for the offences under Section 296(b), 131, 351(3) of BNS and Section 4 of Tamil Nadu Prohibition of Harassment of Women Act, 2002.

2. Pending trial, the parties have entered into compromise and a Joint Compromise Memo has been filed, wherein the de-facto complainant agreed for quashing of the charge sheet.
