Thereafter, the DCB, Thoothukudi, shall conduct an enquiry. If any cognizable offence is made out, appropriate action may be taken in accordance with law within a period of eight weeks from the date of receipt of a copy of this order.

4. With the above directions, this Writ Petition stands disposed of.
There shall be no order as to costs.
