5.Learned Counsel appearing for the respondents 1 & 2 would submit that the representations of the petitioner would be considered by the respondents 1 to 3 in accordance with law, within a time frame to be fixed by this Court.

6.Accordingly, this Writ Petition is disposed of, by directing the second respondent to consider the petitioner's representations dated 25.10.2025 and 02.02.2026 and pass orders after giving due notice to the petitioner as well as fourth respondent, within a period of four [4] weeks from the date of receipt of a copy of this order. There shall be no order as to costs.
