ORDER

2.By consent, this Writ Petition is taken up for final disposal at the admission stage itself.

3.The learned Counsel for the petitioner would submit that the petitioner intending to sell his share of the property in S.No. 92/4 to one Meena, presented the sale deed for registration before the Sub-Registrar, Manachanallur, which came to be refused for getting “no objection” from the respondent herein. In this regard, the petitioner has already submitted a representation to the respondent on 31.01.2026. Since the said representation is pending consideration, the petitioner has come up with the present Writ Petition.

4.Learned Government Advocate appearing for the respondent would submit that the representation of the petitioner
