ORDER

This writ petition has been filed seeking a direction to the 1 and 2 respondents to effect the survey of land and fixing four boundaries in Survey Numbers A/17/128 of Pannipullanvayal Village, Kannangkottai Group, Devakottai Town, Devakottai Taluk, Sivagangai District, with the aid of the third respondent police based on the petitioner's survey application dated 10.05.2024.

2. The petitioner seeks the indulgence of this Court to direct respondents 1 and 2 to conduct a survey and demarcate the boundaries of the aforementioned property, as requested in his application dated 10.05.2024. Learned counsel for the petitioner submits that despite submitting the application on 10.05.2024, no action has been taken by the authorities. Aggrieved by this inaction, the petitioner has filed the present writ petition.
