ORDER

The petitioner seeks the indulgence of this Court to direct respondents 1 and 2 to conduct a survey and demarcate the boundaries of the aforementioned property, as requested in his application dated 30.10.2025. Learned counsel for the petitioner submits that despite submitting the application on 30.10.2025, no action has been taken by the authorities. Aggrieved by this inaction, the petitioner has filed the present writ petition.

3. Learned Government Advocate appearing for respondents 1 and 2 submits that the petitioner's application will be considered on merits and in accordance with law.
