ORDER

The impugned proceedings dated 09.02.2026 has been issued by the third respondent consequent upon the conviction suffered by the petitioner in C.C.No.82 of 2013, on the file of the Judicial Magistrate Court No.II, Virudhunagar. Though the petitioner claimed to have filed a criminal appeal against the said conviction in Criminal Appeal No.222 of 2025, on the file of the Principal District and Sessions Court, Virudhunagar District at Srivilliputtur, the conviction imposed on the petitioner is not suspended.
