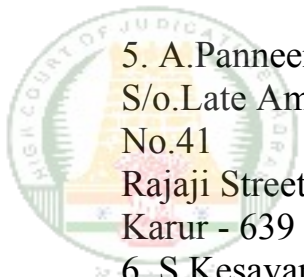

ORDER

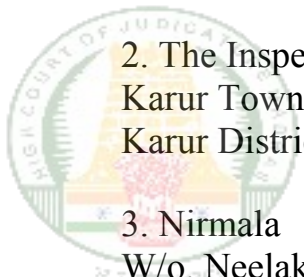
