ORDER

2. The petitioner is a licensed Document Writer. He had submitted an application seeking renewal of his licence. It is stated that the third respondent, by communication dated 15.10.2025, recommended the renewal and forwarded the same to the second respondent. However, the second respondent has not yet passed orders on the said application.

3. When the matter was taken up for hearing, the learned Special Government Pleader submitted that the second respondent would pass appropriate orders on the petitioner's application in accordance with law.
