ORDER

This writ petition has been filed seeking a direction to the respondents to survey the lands and place the survey stones in Survey No. 332/2, to an extent of 0.91.50 hectares (2.26 acres), situated at Mullipadi Village, Kadavur Taluk, Karur District, based on the petitioner's representation dated 21.11.2025.

2. The petitioner seeks the indulgence of this Court to direct respondents 1 and 2 to conduct a survey and demarcate the boundaries of the aforementioned property, as requested in his application dated 21.11.2025. Learned counsel for the petitioner submits that despite submitting the application on 21.11.2025, no action has been taken by the authorities. Aggrieved by this inaction, the petitioner has filed the present writ petition.

3. Learned Special Government Pleader appearing for respondents 1 and 2 submits that the petitioner's application will be considered on merits and in accordance with law.
