The petitioner seeks the indulgence of this Court to direct respondents 1 to 4 to conduct a survey and demarcate the boundaries of the aforementioned property, as requested in his application dated 11.12.2025. Learned counsel for the petitioner submits that despite submitting the application on 11.12.2025, no action has been taken by the authorities. Aggrieved by this inaction, the petitioner has filed the present writ petition.
