2. According to the petitioner, based on the petitioner's representation, the survey has been conducted. However, consequence to the same, the proceedings were not issued.

3. Considering the same, the second respondent is directed to consider the petitioner's claim as per the survey made by the respondents and pass appropriate orders by subdividing the property and issue patta.
