This petition has been filed seeking to direct the respondents 1 and 2 to remove the name of the 3rd respondent herein from the Patta No.8254 and issue the Joint Patta on the name of Petitioners herein along with Chinnu and Chinnan with regard to property in Survey No.247 to an extent of 8 acre 95 cents situated at Ayyalur Village, Vedasandur Taluk, Dindigul District based on the petitioners representation dated 10.02.2026.

2. The learned counsel for the petitioners submitted that the petitioners, along with other co-owners, are entitled to the property by virtue of their inherited rights. It was further stated that a portion of the land had been sold to the third respondent, who subsequently obtained an individual patta in her name. The petitioners apprehend that the issuance of a patta in an individual name may
