2. In the order, dated 20.01.2026, in condition No.5(b), the petitioner was directed to deposit a sum of Rs.30,000/- (Rupees Thirty Thousand Only) to the credit of Crime No.723 of 2025 before the Judicial Magistrate No.VI, Madurai.

3.Considering the reasons stated by the petitioner in the petition, the aforesaid condition imposed in the anticipatory bail petition will affect the fair trial of the case and it is onerous.
