### **ORDER**

The present criminal original petition has been filed by the petitioner/sole accused in C.C.No.117 of 2024, on the file of the learned Judicial Magistrate, Aruppukottai, wherein the petitioner/sole accused has been charged for the offence under Sections 294(b), 326 and 506(ii) of IPC.

2. Pending trial, the parties have entered into compromise and a Joint Compromise Memo has been filed, wherein the de-facto complainant agreed for quashing of the charge sheet on the ground that they have started living together. The de-facto complainant is present in person and she also acknowledges the fact that she has agreed for quashing of the charge sheet.
